  - d. What ministries are devoted to meeting urgent needs in one area?
  - e. What urgent needs do you see going unmet at this time? i. Any suggestions?
- III. Now read <u>Titus 3:8</u>. Suggest ways that we can encourage our church members to carefully devote themselves to doing what is good.
  - a. What should we do for Christians who are failing in the area of good works?
  - b. Read <u>Micah 6:8</u>. According to this verse, what does the Lord consider "good" for his people?
  - c. What kinds of things signify acting justly? How about mercy?
  - d. What does walking humbly with God look like?
